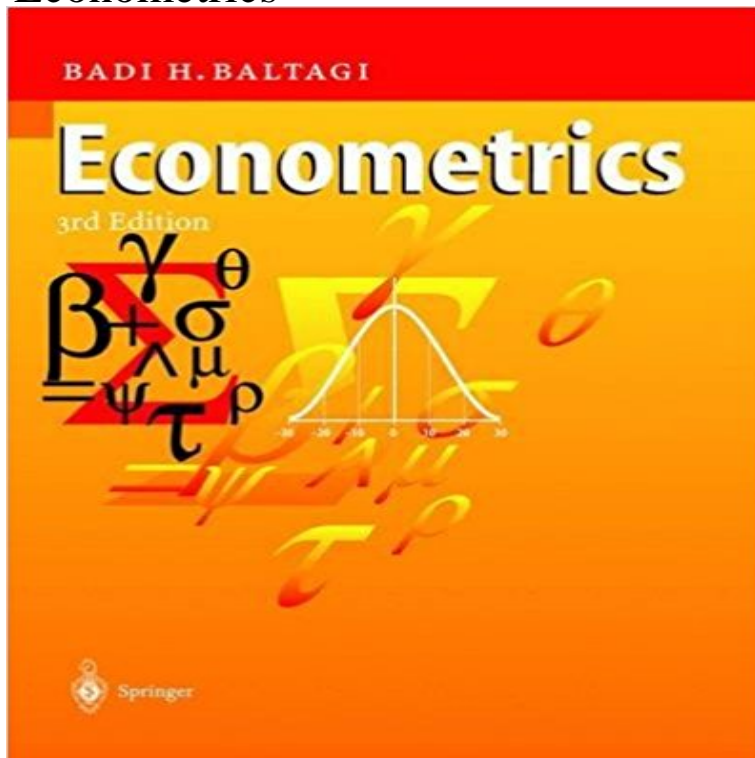


Econometrics
